- The vehicle allocation shall be confirmed based on milk availability. At present, Theni Milk Union has approved the allocation of 2 vehicles.

- Total Distance per Day: 270 km approx.
- Contract Period: 1 Month (August 2026 only)

Eligibility Criteria

- The contractor should be able to provide the required number of milk tankers as per the work requirement.
- 15 KL Milk Tanker availability is mandatory (Requirement: 3 Nos.).
- Contractor should have valid documents for vehicles (RC, Insurance, Fitness Certificate, Permit, Pollution Certificate, etc.).
- Tankers should be suitable for milk transportation and maintained in a proper hygienic condition.
- Contractor should arrange additional tankers whenever required by Theni DCMPU / Sister Unions.
- The EMD shall be liable for forfeiture if the winning bidder does not execute the contract and fails to furnish the Security Deposit (SD) in specified time, and the EMD shall not carry any interest.

Additional Note:. On confirmation of receipt of material by Union, NCDFI eMarket will release the EMD within one working day, after adjusting the transaction charges @ 0.30% of total trade value which is exclusive of GST. TDS (u/s 194-O) @ 0.1% TDS u/s 194 (O) will be deducted from the seller's EMD on the projected trade value at the time of issuance of the Bid Evaluation Result.
