Additional Notes

1. Only Plastic Waste Registered Recyclers are allowed to participate in the auction.
2. Above given quantity is approximate which may vary, Winner have to lift entire lot during the contract period for respective items.
3. Bidders need to quote Ex-Dairy rate in Rs./Unit mentioned above exclusive of applicable GST, Transportation and other expenditures.
4. If the actual quantity vary +/-20% of the bid quantity in such cases no additional invoice/refund shall be done in the transaction charges
5. Lifting shall be carried out only after receiving proper authorization and a valid gate pass from the concerned department.
6. Scrap material must be weighed at the company's approved weighbridge before and after loading. Final billing will be based on the actual weight recorded.
7. Scrap must be lifted within the stipulated time frame mentioned in the work order or as directed by the plant authority.
8. Scrap vehicles entering the plant premises must comply with plant safety norms and security checks.
9. Loading personnel must wear proper safety gear (helmet, shoes, etc.).
10. The vendor must ensure proper handling and segregation of scrap as per its category (plastic, metal, paper, etc.).
11. Any damage caused to plant property during scrap loading will be recovered from the vendor.
12. All applicable taxes (GST, TCS, etc.) must be borne and paid by the buyer as per prevailing laws.
13. Payment shall be made as per the agreed terms, preferably via bank transfer.
14. The vendor must ensure environmentally compliant scrap disposal in accordance with local and central pollution control board norms.
15. The plant management reserves the right to cancel the lifting order without prior notice in case of non-compliance with any of the above terms.
