3)Contract period –01 Oct 2026 to 30 September 2028. (2 Years)

4)The prevailing rate of Diesel in Delhi Rs 95.20/ litre as on 6th August 2026.

5)Number of trips may increase & decrease based on the business requirement.

3)Eligibility Criteria:

1. Valid FSSAI License
2. At least 2-year experience of transportation in similar industry/FMCG/Retail/E-commerce/
3. Signed and Stamp on Terms and Condition
4. Signed and Stamp on Declaration

5)MDFVPL at its own discretion can award the routes to multiple bidders.

6)MDFVPL at its own discretion can have multiple rounds of negotiation offline/online/ through reverse auctions among the technical evaluated bidders.

7)Transaction Charges: TC@0.3% of contract value (plus GST) and advance TDS@0.1% of the actual contract value. Mother Dairy will communicate the actual trade value for every vendor in the contract. Based on the shared actual data, the TDS and TC will be deducted/adjusted for the next quarter vendor-wise. If at any point in time, EMD is found to be insufficient, the vendor needs to deposit Balance EMD to continue the contracted transportation. At the end of the contract period, TC will be adjusted as per actuals for full and final adjustments and balance EMD will be released.

8)Forfeiture of EMD: The EMD submitted by the Bidder shall be forfeited in any of the following conditions. However, MDFVPL reserves the right to override any of the following conditions at its sole discretion. The Bidder withdraws his Bid after submitting the same. The Bidder withdraws his Bid after the Notification of Award. The selected Bidder withdraws the proposal before submitting the Security deposit. Failure to accept the order by the selected Bidder within 7 days from the date of receipt of the notification of Award.

9)EMD will be blocked for all participants until final confirmation is received from MDFVPL.
