- The rates quoted should be in Rs for Per Qtl, FOR our Plants inclusive of all taxes and excluding normal unloading and mamool charges. Normal unloading charges and mamool charges will be borne by the respective Plants. However additional unloading charges if any incurred in connection with torn bags or overweight bags with more than 55Kg will be borne by the supplier itself. Prevailing rate of additional unloading charge will be considered for arriving expenses for additional unloading at respective plants.

1. Technical Grade Urea

- Mention Source of supply.
- The bidder of Urea should produce a self-attested form stating that supplied urea is Industrial (Technical) and free from neem content.
- Supplier should directly procure and supply Technical Grade Urea from GNFC manufactured/ GSFC/Authorized dealers of Indian Potash Ltd and sufficient proof of the documents shall also be attached.
- Supplier should include quality analysis report from approved lab for the particular consignment indented for supply.

2. Soya bean Meal

Copy of the Analysis Report from a reputed NABL accredited lab shall be produced along with the material in the Plant along with the invoice.
