- Quotation to be submitted on Dedicated Mode. (Single/Multiple Drop Points).
- Base Average Diesel Rate for quote calculation is Rs. 99.81/- September-2026 (monthly average) of Kolkata to be considered.
- Freight rate should include all pocket expenses. i.e. loading/unloading/ Warai/Parking. Toll Tax will be paid on Actual Basis. (Supporting Documents – i.e Fast-Tag, Toll Receipt required to submit as supporting at time of Bill Submission)
- Eligibility Criteria-
 - Service provider should have at least 2-Year experience of transportation in similar/FMCG industry.
 - The vehicle(s) should be registered in the name of the owner, relative, company, or lessor (in case of a leased vehicle). A copy of the proof of Registration Certificate (RC) and, for leased vehicles, a valid lease agreement must be submitted. “Relative” in relation to the bidder means the husband, wife, brother, sister, or any lineal ascendant or descendant of the bidder. The overall owner must possess at least 10 vehicles.
 - Vehicle age should be not older than 6 years.
 - Valid FSSAI License.

5. Sign stamp on the terms and condition.

5. Transaction Charges: TC @ 0.2% of contract value (plus GST) and advance TDS @ 0.1% of the actual contract value. Mother Dairy will communicate the actual trade value for every vendor in the contract. Based on the shared actual data, the TDS and TC will be deducted/adjusted for the next quarter vendor-wise. If at any point in time, EMD is found to be insufficient, the vendor needs to deposit Balance EMD to continue the contracted transportation. At the end of the contract period, TC will be adjusted as per actuals for full and final adjustments and balance EMD will be released.

6. Forfeiture of EMD: The EMD submitted by the Bidder shall be forfeited in any of the following conditions. However, MDFVPL reserves the right to override any of the following conditions at its sole discretion. The Bidder withdraws his Bid after submitting the same. The Bidder withdraws his Bid after the Notification of Award. The selected Bidder withdraws the proposal before submitting the Security deposit. Failure to accept the order by the selected Bidder within 7 days from the date of receipt of the notification of Award.

7. EMD will be blocked for all participants until final confirmation is received from MDFVPL.

8. MDFVPL at its own discretion may have multiple rounds of negotiation if so, required via offline(Single/Multiple bidders)/online/ through reverse auctions among the technical evaluated bidders. In case of reverse auction(as a part of negotiation),initial bid or any rate offered offline while negotiation submitted by the bidders will remain valid till bid validity. it will be sole discretion of MDVPL to consider the either auction rate or tender rate or any rate quoted during the process.
