2. The quantities mentioned are tentative and may change as per the business requirement.

3. The NCDFI eMarket transaction fees (i.e 0.4% of trade value + GST) would be deducted from the EMD of the suppliers held at NCDFI on actual supply after getting the confirmation from Mother Dairy.

4. Breakup: The successful bidder shall have to provide a complete breakup of the quoted price.

5. TDS amount (0.1 % of total trade value) is included in EMD.

6. The EMD has been fixed for the convenience of the bidders, however post-approval of contracts, for any particular bidder, if the amount of EMD is not sufficient with respect to tentative quantity for maintaining 1.50% of the trade value with the NCDFI eMarket, the respective member (winning bidder) has to deposit the balance EMD to comply with 1.50% EMD Requirement. In such a scenario the Bid Evaluation Result will be issued in favor of the bidder only after deposition of the balance amount with the NCDFI Market.
