Pre-Qualification Criteria :

1. The eAuction participants should be a Manufacturer of the same type of Printed Laminated Film Roll.
2. The EMD will be forfeited under the following circumstances: if the bidder fails to accept the quoted rate, submits an incorrect quotation, is not a legitimate Manufacturer of the specified product, or raises any unwarranted objections after the bidding process.
3. The bidder shall be liable for termination from participation in the NCDFI e-Auction and for cancellation of the Purchase Order, EMD will be forfeited in the event of any of the following:
 - a. Failure to supply the material as per the delivery schedule prescribed by AAVIN;
 - b. Supply of material of inferior or sub-standard quality;
 - c. Supply of defective material or material not conforming to the prescribed specifications, tender conditions, or Purchase Order; or
 - d. Failure to respond to the communications, instructions, or calls issued by AAVIN within the stipulated time.
4. The successful L1 bidder on the NCDFI eAuction must submit samples of the same type of Printed Laminated Film Roll as per the defined specifications, for quality testing, if required.
5. The quantities mentioned in the eAuction are approximate. The eAuction accepting authority shall be permitted to vary the quantities finally ordered and execute the work through the contractor to the extent of 25% (Twenty five percent) either way of the requirements as per TCMPE Ltd. / NCDFI eMarket terms & conditions.
